Direct from the Director

In the middle of January I attended the Mid-Winter Board of Directors' Meeting. I was forced to leave knee deep snow in Valparaiso and travel to St. Petersburg, Florida for a weekend. It was tough duty and my wife volunteered to accompany me so that I wouldn't have to endure it on my own. She enjoyed the sunny days and nearly 70 degree weather, while I enjoyed sitting, and sitting, and sitting in the special session on Saturday and the board meeting on Sunday.



The Sunday board meeting was packed with information and discussion. Here's a short summary. The following policy statements were approved: Cross Connections, Finance, Accounting and Rates, Operator Certification, Safety, Research, Diversity and Nondiscrimination, and Climate Change. We approved changes to the bylaws for a couple of sections. Several amendments to the Association Bylaws and Governing Documents were approved.

The primary change was to eliminate Water For People from the AWWA Executive Committee. Water For People has come a long way from its start within AWWA. There comes a time when every parent realizes their child has grown up and it's time to cut them loose. Water For People has become an entity onto itself and gathered supporters from outside of the water industry and AWWA membership.

One of the Approved amendments to Governing Documents was Article IV. Language was added for the Standards Council, to comply with ANSI requirements. This will prevent a discrepancy between AWWA Standards and ANSI requirements from occurring.

The board approved eighteen standards. Six of the standards were water meter related, a couple were related to pipe and a couple were for tanks. The rest were standards for Liquid Chlorine, Calcium Chloride and others for those of you interested in water treatment and production.

Being Indiana's Awards committee chair I was very interested in the approval of award recipients. There was one for a utility in Indiana. You will have to wait until June and the Association's Annual Conference (ACE 10) in Chicago to find out who!

The Association's Treasurers Report and 2010 budget were approved - all 240 pages. It's an amazing organization to which we belong. Although sales and revenues were down due to the economy, our professional staff managed to get the job done and keep expenses down ending the year with a small profit. Our staff can be commended for their efforts working short handed and doing what was needed often outside of their own job classification. They deserve our appreciation and thanks.

Also deserving of our thanks are those directors who volunteered for a much heavier work load by running for board positions. It was very tough to pick who to vote for from a slate full of excellent candidates. I have to believe that every one of the candidates would have done a fine job for our association and our membership. We elected four new vice presidents. One was our neighbor to the west, my good friend John Donahue from the Illinois section. Another also from the Midwest was my new friend Jim Chaffee from the Wisconsin Section.

The Mid-west is further represented on the Executive board with the election of Jerry Stevens from Iowa to serve as the Association's President-Elect for a one-year term beginning in June 2010, followed by a one-year term as President beginning in June 2011. I would have liked to have vote for all three of the fine candidates for President Elect. I had to vote for just one and it was Jerry. You should remember Jerry; he was our visiting dignitary at our February 2009 annual conference. I thought Jerry gave a very powerful, energetic, and presidential like speech. Apparently, the majority of directors felt the same way.

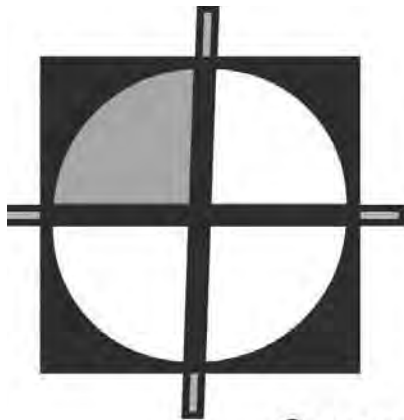

The Indiana Department of Environmental Management (IDEM) is presently finalizing new regulations for sanitary surveys for Community and Non-Community water systems. While the basic criteria for sanitary surveys have not radically changed, one important new component is the definition of "significant deficiencies". If a deficiency is identified during a sanitary survey, compliance will be determined based on a water system's correction of these deficiencies. The Education Committee is planning to conduct three workshops this spring to provide operators information on the sanitary survey process, preparing for your next sanitary survey and how to identify and correct deficiencies in the eight elements of a sanitary survey.

The workshops are currently being developed and will be held as follows:

- May 11, 2010 – Rochester, Indiana
- May 18, 2010 – Indianapolis, Indiana
- May 25, 2010 – Huntingburg, Indiana

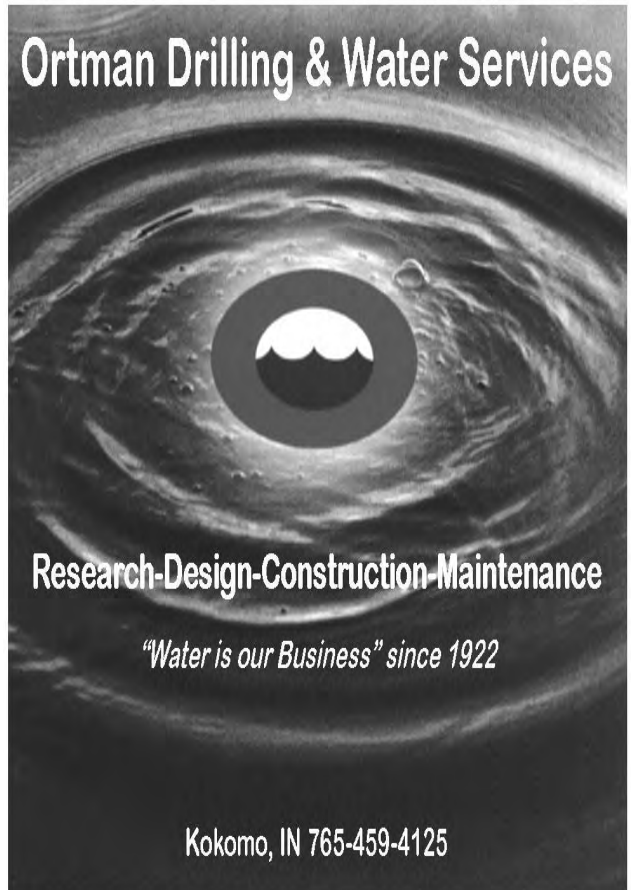

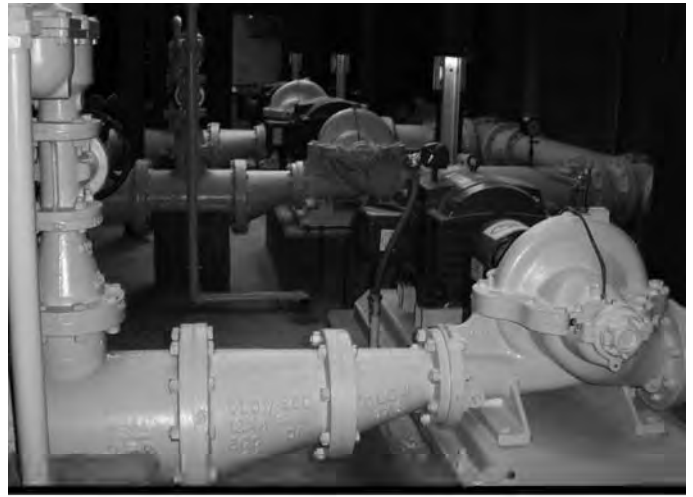
