

Direct from the Director

This year's mid-winter board meeting was held in sunny, warm San Antonio, Texas. Unfortunately, when we arrived it was neither sunny nor warm. (When I say we I mean me and my body guard, aka my wife Pamela.) San Antonio was experiencing below normal temperatures. It was unbelievably cold, that's what the locals kept telling me. I was pretty happy with 52 degrees as when we left Valparaiso that morning the temperature was 1. That's right, 1 degree with a wind chill of -20 degrees. From our perspective San Antonio was warm.

On Saturday at the Board Special Session we went over the Treasurer's Report and the proposed 2011 budget. It's hard for me to get used to our Association's twenty-eight million dollar budget. After the budget review we had a presentation on Facilitating Partnerships followed by a round table discussion of other organizations that AWWA might partner with on particular items when we might have a common goal. Some of the groups were very successful at thinking outside the box and generating some creative ideas.

There was a membership update by Susan Franceschi, AWWA's Chief Membership Officer. The steady decline in membership and the reduction in number of dues paying members is very concerning. Our largest growing grade of membership is our Life Members, those individual members who have maintained continual membership for thirty years. Past practice has been that paying dues is optional for life members. I encourage all of you who are Life Members and are still working, to continue to pay your membership dues. Staff is evaluating the levels of individual membership and may recommend a plan to revise them.

The work session concluded with a presentation from the Diversity & Member Involvement Committee by fellow director Martin Garcia. Martin spoke about the committee's definition of Diversity, which is that Diversity isn't just about differences in sex, race, or religion, but also backgrounds, education, and experiences. There were a few closing announcements and we adjourned.

The Sunday board meeting started off with a welcome from our President, Joe Mantua, followed by a few announcements, roll-call, and the elections. First on the agenda was the election of the next AWWA President-Elect and four Vice Presidents.

The two candidates for President each had 5 minutes to speak and then the vote was taken. Next were the 5 minute presentations by the six candidates for Vice President, starting with the Director from Indiana. I thought he did a pretty fair job, got a few laughs and finished early. The other candidates each took their turn to speak and the vote was taken. There were three candidates for Director-at-Large and three candidates for Service Provider Director-at-Large. Following the elections we took a short break and there was a lot of handshaking and offering of congratulations all around. Some of the candidates, at least one that I know of, needed to make a wardrobe change and get back in their jeans.

After the break, the vote was taken to approve the items on the Consent Agenda which comprised about a hundred pages of our meeting notebook. Here's a short summary of those items: approval of changes to the bylaws for several sections - Atlantic Canada, Intermountain, North Carolina, Puerto Rico, South Dakota, and Wisconsin; and the following policy statements were approved - Management of Groundwater, Sustainability, Water Quality Control in the Distribution Center, Assignment of Continuing Education Credit and Professional Development Hours, and Water Use Efficiency.

There was one new standard, B300a Hypochlorites Addendum. There were thirteen revised standards. These ranged from B502 Sodium Polyphosphate to D104 Automatically Controlled, Impressed-Current Cathodic Protection for the Interior Submerged Surfaces of Steel Water Storage Tanks.

The board approved several action items and the Treasurer's report. One of the more interesting items was the ratification of Toronto as the future site for ACE 2023 and 2029. Toronto will be replacing Orlando in the six city rotation. Toronto's new Direct Energy/Allstream Centre is located five minutes from downtown Toronto. The two buildings are connected by an underground walkway. The exhibit space is over 470,000 sq. ft. of continuous space which gives us room to grow.

The most interesting item on the Treasurer's Agenda, for those of us from Indiana, was the ratification of the appointment of our very own John Seever to the Audit Committee. Thank you John for stepping forward and volunteering for what I'm sure must be a grueling task. I didn't particularly enjoy reviewing the line items of a twenty-eight million dollar budget and you volunteered to help audit it. We need more volunteers like John, those who are ready to roll up their sleeves and go to work for our association.

There were some other items on the agenda that are less exciting then those I've mentioned and the board meeting concluded right on schedule.

You'll notice this time I tried to be a professional and didn't write anything about all of the sitting.
