The program will be posted and mailed out once confirmed.

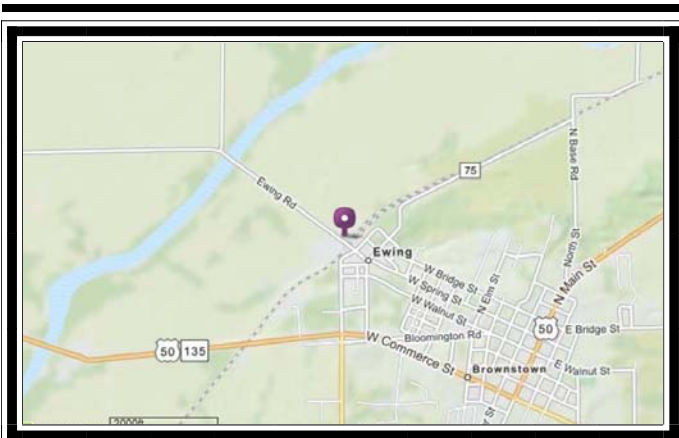
Please dress for weather and construction site conditions. Also, feel free to **bring your own folding chair** to use during outdoor demonstrations.
